#### **OUR VISION FOR THIS MERGER IS:**

The "Stronger Together" vision of the combined colleges will:

- Deliver innovative and ambitious high-quality post-16 education, meeting local, regional and national skills needs
- Harness the strengths of all staff, students and stakeholders, empowering individuals through a supportive culture of excellence
- Enhance collaboration and growth by working closely with stakeholders, communities and employers leading to regional development.

This unique opportunity will allow us to address the regional skills gaps and support high-demand industries by boosting local employment. It will also mean we can further invest in our students, prioritising advanced facilities and technologies for an enriched, student-centred learning environment.

### Why Should SMB College Group and Loughborough College Merge?

The recommendation for SMB College Group to merge with another college was one of the outcomes of a Structures and Prospects Appraisal (SPA) process led by the Further Education Commissioner. Loughborough College was selected as the preferred merger partner by the SMB College Group board due to similarities in both colleges' values and strategic goals, in addition to complimentary but distinct curriculum offerings across their four campuses.

It is envisioned that combining the resources and expertise of both colleges will offer a transformative opportunity to create a unified organisation which enhances opportunities for all key stakeholders across North Leicestershire and beyond, whilst also ensuring the long-term financial resilience of the merged entity.

### BENEFITS FOR STUDENTS

- **STUDENT EXPERIENCE:** The merger will allow the joint organisation to prioritise high-level investment into both curriculum and student experience, ensuring that all learners have an excellent, well-rounded and enriching experience whilst gaining their nationally recognised qualifications.
  - INDUSTRY PARTNERSHIPS AND EMPLOYABILITY: Students will benefit from the wellestablished reputations and course specialisms of each campus, which attract excellent industry partnerships and employability opportunities.
    - **BROADER STUDY OPTIONS:** An enhanced course portfolio will be available for further education students, apprentices, higher education students, adult learners and international students to choose from. This will also contribute to enhanced progression opportunities for students.
      - expertise, bespoke industry-standard facilities and on-site accommodation at both colleges. In addition, planned developments and ongoing investment at both campuses will ensure high-quality learning environments, such as a new Agri-tech centre at Brooksby Campus and a new Sports facility at Loughborough.
        - **CONTINUITY:** In the academic year immediately following the merger, students will see very little change in their course or campus of study.
          - **EMPLOYER PARTNERSHIPS:** Merging the colleges' employer networks will provide additional work experience, apprenticeships and job opportunities for learners, increasing employability outcomes.
            - COMMITMENT TO EDI: The merged entity will retain both colleges' commitment to Equality,
               Diversity and Inclusion, and looks forward to championing this across its newly expanded
               student body.

## BENEFITS FOR STAFF

- QUALITY AND BEST PRACTICE: Combining teaching resources and expertise, and sharing best practice, will allow the merged college to achieve the highest levels of quality.
- **SECTOR SPECIALISMS:** The merged entity will be positioned as a sector leader in multiple curriculum areas, bolstered by access to a broader range of resources across the newly merged college. This will lead to increased opportunities to attract and work alongside key employers within specialist sectors.
- SHARED RESOURCES AND FACILITIES: Staff will have the opportunity to access the
  modern, industry-standard facilities shared by both colleges. These modern, specialist
  facilities include Loughborough's T-Level Centre, the extensive land-based facilities at
  Brooksby and the trade and engineering capabilities at Stephenson. Future investments in
  infrastructure will also strengthen the merged entity.
- **FINANCIAL RESILIENCE:** The merger will provide enhanced financial stability for both colleges, with a focus on ensuring long-term financial adaptability and sustainability.
- **CONTINUED PROFESSIONAL DEVELOPMENT:** The enhanced resources and curriculum offerings of the merged organisation will provide additional opportunities for staff to develop new skills and experience through professional qualifications, online learning, higher education and apprenticeships.
- **GROWTH AND PROGRESSION:** Additional opportunities provided by the larger merged organisation can provide staff with enhanced progression opportunities, including leadership development.

## BENEFITS FOR EMPLOYERS

- **SECTOR LEADERS:** Employers will have increased opportunities to enhance and develop working relationships with an organisation with multiple sector specialisms. Through a widening of curriculum capabilities, the merged college will be able to support businesses across a wide range of areas and departments via training, upskilling, work experience and apprenticeship services.
- **LOCATION AND FACILITIES:** The merged organisation provides a centralised location for apprenticeships, training, staff development and conferences with a wealth of resources, expertise and venue types to suit employer requirements. Employer partners will also have increased access to a range of industry-standard facilities across the college's four campuses for training and development purposes.
- INCREASED CAPACITY: The merged college will have an increased capacity to
  respond to employers' training and apprenticeship needs across North Leicestershire
  and beyond, with a centralised approach to reviewing business needs and
  implementing training and development plans.
- **SKILLS AND EMPLOYABILITY:** The merged college will have increased capabilities for collaborating with employers to address Local Skills Improvement Plan (LSIP) priorities. Employers will be presented with more opportunities to collaboratively codesign and develop curriculums, allowing them to further influence skills development within the future workforce and contribute to economic development and stability within of the region.
- **NETWORKING OPPORTUNITIES:** The amalgamation of both colleges' employer and partnership engagement activities will provide increased networking opportunities and allow employers access to wider pool of students to promote vacancies and placement opportunities.

# **SMB COLLEGE GROUP:** STATUTORY NOTICE

#### FURTHER AND HIGHER EDUCATION ACT 1992

Notice is hereby given by the Corporation of SMB College Group (Thornborough Road, Coalville, LE67 3TN), in accordance with the Further Education Corporations (Publication of Proposals) (England) Regulations 2012, of the proposal for the transfer of the property, rights and liabilities to the Corporation of Loughborough College (Radmoor Road, Loughborough, LE11 3BT) and the subsequent dissolution of the Corporation of SMB College Group.

Dissolution of the Corporation of SMB College Group is proposed in order that it may merge with Loughborough College. The merger will create a strong institution delivering high-quality education and skills training for learners and employers across Leicestershire.

The date proposed for the dissolution of the Corporation of SMB College Group is 1st August 2025.

All students at SMB College Group who have not yet completed their course of study by the date of the proposed dissolution will continue their education in the merged college on the same campus where they studied immediately prior to the dissolution of the Corporation of SMB College Group. This will affect approximately 3400 students: 2100 16-18-year-olds (FE learners) and 1300


The consultation period runs from 24th March to 30th April 2025.
